Require libraries to filter Internet access to prohibit access to pornographic and obscene sites.

Sexual education programs that depict condoms as an effective way to prevent STDs including HIV.
Permit a court-approved Bible history course may be taught as an elective.
Implementing curriculum that teaches K-6 grade students about HIV/AIDS & other sexually transmitted diseases.
Article 1, Section 27 of the Florida Constitution which defines marriage as between one man and one woman should be enforces as the legal definition for marriage in Florida.
Contracting for services from medical groups that also offer abortion counseling including Planned Parenthood.
Health insurance provided for "same sex" and live-in partners for employees of local government.
Allow individuals to use the bathroom they self identify with rather than the bathroom that matches the gender on their birth certificate.
Give "sexual preference, sexual orientation or lifestyle" minority protection status equivalent to that currently covered under existing civil rights laws.
Stressing basic academic skills (i.e. reading, writing, mathematics) over social programs (i.e. health care issues, social engineering, values clarification issues, etc.)
The combined total of state, federal, and local taxes should amount to what percentage of a person's earning?
Require businesses to provide services for homosexual weddings even if their religious beliefs oppose homosexual marriage.
Amend DOE Curriculum Framework for Biology and Life Science to allow the teaching of life by intelligent design.
Gambling in the county should be expanded as a source of new revenue and jobs.
Tax funded education vouchers that allow parents to choose public or private schools.
Encourage and support a quality chapel in the County Jail.
Use of tax revenues for condom distribution.
Exempt private schools from costly fees, regulations, building codes from which public schools are already exempt.
Abstinence based sex education that gives information on refusal skills, STD's, contraceptives with their failure rates and no demonstration of condoms.
Require individuals prove they are legal citizens prior to receiving welfare or government assistance.
