Use of tax revenues to support programs at health clinics that offer contraception to minors without parent consent.
Health insurance provided for "same sex" and live-in partners for employees of government agencies.
Add "sexual preference, sexual orientation or lifestyle" minority protection status equivalent to that currently covered under existing civil rights laws.
Stressing basic academic skills (i.e. reading, writing, mathematics) over social programs (i.e. social engineering, political advocacy on specific issues, organizing political protests, etc.)
Teaching reading by a strong phonics curriculum as opposed to a whole language approach.
Amend DOE Curriculum Framework for Biology and Life Science to allow the teaching of life by intelligent design.
The majority of members on school committees with policy making authority should be parents and persons other than school board employees or their relatives.
Allowing school-based clinics to dispense birth control devices.
Florida Statute 1003.46 reads in part that Health education should "Teach abstinence from sexual activity outside of marriage as the expected standard for all school-age students."
Article 1, Section 27 of the Florida Constitution which defines marriage as between one man and one woman should be enforced as the legal definition for marriage in Florida.
Prevent or restrict use of office or commercial property by churches.
Require businesses to provide services for homosexual weddings even if religious beliefs oppose homosexual marriage
Display crosses, nativity scenes, menorah, and other religious items on public property with secular items, as part of a seasonal celebration.
Open government board meetings with a word of prayer.
Allow continuation of Sanctuary Cities in Florida.
